## **HELP FIGHT LABOUR EXPLOITATION**

#### What is labour exploitation?

- Employers do **not** pay minimum wages.
- There are **no** or only **a few days** off.
- You do not receive any money when you are ill or on holiday.
- You have to work **more** hours than allowed.

## JOB-RELATED COUNSELLING

- You were given notice by your boss; your employment contract was **not** renewed.
- There was no **written** termination.
- Your job is dangerous and damages your health.
- There is **no** protective clothing and protective equipment.
- Your employer retained your passport / ID.

## **HELP IN DEALING WITH AUTHORITIES AND PAYMENTS**

### In which cases are you entitled to payments?

- You are ill and you can**not** work.
- Your rent is high and you need a **housing** allowance.
